  - b) None of the boxes in the ballot form are crossed;
  - c) The ballot form is incomplete or unsigned; or
  - d) The outside of the envelope does not have the name or signature of the member.
- 5. The completed and signed postal ballot form must be received by the Honorary Secretary of the Society at MNS Headquarters no later than 4.00 pm on Wednesday, 18 September 2024 (two working days before the date of the AGM).
- 6. Ballots delivered by hand must be in the hands of the Chairman of the AGM by the time scheduled for the commencement of the meeting (no later than 10am on 21 September 2024) and will only be opened at the time of the meeting.
- 7. Postal ballots once delivered to the Honorary Secretary or the Chairman cannot be withdrawn.
- 8. The nominees' profiles can be viewed and downloaded from MNS website (<a href="www.mns.my">www.mns.my</a>). You will need to log in with a generic username and password at the "Member Login" section as indicated below:-
